## From resistance to collaboration: creating European music therapy training standards

Music therapy education is facing challenges. Within the current neoliberal market, many areas of the arts and humanities are in danger (Brazzill, 2020). Additionally, previous qualification standards across Europe lacked inclusiveness and prompted resistance among music therapists. Within this context, the European Music Therapy Standards (EMTS) commission began work in 2017 to develop competence-based suggested standards for European music therapy training. A "bottom-up" process was used with the intention of hearing the voices across the entire spectrum of music therapy training in Europe (EMTS, 2023).

The commission asked the following questions: What determines a qualified music therapist in Europe? What frameworks or emphases are included within the training programmes? Must all music therapists use the same models, methods and interventions? Is one model or method suitable for use with all client populations?

A survey was sent to all music therapy training programmes in the member countries of the European Music Therapy Confederation (EMTC). After analysing and categorizing the data, competencies deemed necessary for safe and effective practice upon entrance into the music therapy profession were defined. The work of the commission has not yet ended, with further issues needing clarification and development.



In this panel discussion, the commission's work will be summarized. The suggested standards will be presented briefly. Issues such as diversity, underpinning traditions, terminology, varying conceptual models relating to health and wellbeing, and cultural issues will be discussed. The experiences in working in an international group of music therapists and exploring the varied challenges presented by the work and the context for the study will be presented.
